Enrollment Agreement for 2026-2027 School Year

I understand and agree to the following:

1. The Cross Creek Christian Academy school year begins on September 1st, 2026 and ends on May 28th, 2027. Yearly tuition amounts will be set as follows for the 2026-2027 school year: \$4,750 per academic year for students enrolling in Kindergarten- 12th grade (traditionally taught). A 10% sibling discount will apply to the second and subsequent child enrolled within the same family.
2. Attendance at Cross Creek Christian Academy is a privilege, and the school reserves the right to not accept any student for any reason based on details outlined in the Student/Parent Handbook or dismiss any student who does not respect its spiritual standards or cooperate in the educational process.
3. The administration has full responsibility for placing my child(ren) in the grade level they deem fit for my child based on diagnostic testing, transcripts, and upon working with my child.
3. School begins at 8:30 am and ends at 2:30 pm daily. Families whose students are not picked up by 2:30 will be charged the after-school rate of \$12.50 per hour, regardless of pick-up time. Please make your transportation provider aware.
4. Tuition payments for each month are due in advance, on 1st of each month. All checks should be made payable to Cross Creek Christian Academy. Failure to keep tuition payments current may result in discontinuation of enrollment. There will be a \$30 fee for any returned checks.
5. I have read the Student/Parent Handbook and understand the contents. Furthermore, I will openly support them in the presence of my child(ren).
6. I will not allow my child, presently enrolled or transferring to Cross Creek Christian Academy, to utilize classwork (i.e. answer keys, class notes, tests, quizzes, homework, labs, etc.) from this or another school that will undermine their responsibilities academically.
7. I understand Cross Creek Christian Academy does not carry medical insurance on its students. Parents are encouraged to consult with their insurance professional to make sure that their child is covered to/from and while at Cross Creek Christian Academy.
8. By signing this enrollment form, I give up my rights to pursue any legal actions or suits for any reason against Cross Creek Christian Academy and Cross Creek Community Church Ministries.

What We Believe

1. God...is the Creator and Ruler of the universe. He has eternally existed in three personalities: the Father, the Son, and the Holy Spirit. These three are co-equal and are one God. Gen. 1:1,26,27, 3:22; Ps. 90:2; Matt. 28:19; 1 Peter 1:2; 2 Cor 13:14

2. Jesus Christ...is the Son of God. He is co-equal with the Father. Jesus lived a sinless human life and offered Himself as the perfect sacrifice for the sins of all people by dying on a cross. He arose from the dead after three days to demonstrate His power over sin and death. He ascended to Heaven's glory and will return again someday to earth to reign as King of Kings, and Lord of Lords. Matt. 1:22, 23; Is. 9:6; John 1:1-5; 14:10-30; Heb. 4:14,15; 1 Cor. 15:3,4; Rom. 1:3,4; Acts 1:9-11; 1 Tim. 6:14,15; Titus 2:13

3. The Holy Spirit...is co-equal with the Father and the Son of God. He is present in the world to make men aware of their need for Jesus Christ. He also lives in every Christian from the moment of salvation. He provides the Christian with power for living, understanding of spiritual truth, and guidance in doing what is right. He gives every believer a spiritual gift when they are saved. As Christians, we seek to live under His control daily. 2 Cor. 3:17; John 16:7-13, 14:16,17; Acts 1:8; 1 Cor. 2:12, 3:16; Eph. 1:13; Gal. 5:25; Eph. 5:18

4. The Bible...is God's Word to us. It was written by human authors, under the supernatural guidance of the Holy Spirit. It is the supreme source of truth for Christian beliefs and living. Because it is inspired by God, it is the truth without any mixture of error. 2 Tim. 3:16; 2 Peter 1:20,21; 2 Tim. 1:13; Ps. 119:105,160, 12:6; Prov. 30:5

5. Human Beings...are made in the spiritual image of God, to be like Him in character. People are the supreme object of God's creation. Although every person has tremendous potential for good, all of us are marred by an attitude of disobedience toward God called "sin". This attitude separates people from God and causes many problems in life. Gen. 1:27; Ps. 8:3-6; Is. 53:6a; Rom. 3:23; Is. 59:1, 2

6. Salvation...is God's free gift to us but we must accept it. We can never make up for our sin by self-improvement or good works. Only by trusting in Jesus Christ as God's offer of forgiveness can anyone be saved from sin's penalty. When we turn from our self-ruled life and turn to Jesus in faith we are saved. Eternal life begins the moment one receives Jesus Christ into his life by faith. Rom. 6:23; Eph. 2:8,9; John 14:6, 1:12; Titus 3:5; Gal. 3:26; Rom. 5:1

7. Eternal Security...because God gives us eternal life through Jesus Christ, the true believer is secure in that salvation for eternity. If you have been genuinely saved, you cannot "lose" it. Salvation is maintained by the grace and power of God, not by the self-effort of the Christian. It is the grace and keeping power of God that gives us this security. John 10:29; 2 Tim. 1:12; Heb. 7:25, 10:10,14; 1 Peter 1:3-5

8. Eternity...people were created to exist forever. We will either exist eternally separated from God by sin, or eternally with God through forgiveness and salvation. To be eternally separated from God is Hell. To be eternally in union with Him is eternal life. Heaven and Hell are real places of eternal existence. John 3:16; John 14:17; Rom. 6:23; Rom. 8:17-18; Rev. 20:15; 1 Cor. 2:7-9
